Dear Mr. Koons:

This is in response to your February 5, 2008, request for clarification involving disposal of solidified hydrocarbons (gasoline, diesel fuel, refined motor oils) in amounts of less than five gallons. The hydrocarbons will be solidified using C.I.Agent polymers.

Under 40 CFR § 262.11, as incorporated by reference under 25 Pa. Code § 262a.10 as modified at § 262a.11, it is the responsibility of the generator to determine if the solidified spill residue is a hazardous waste. If it either exhibits a characteristic of hazardous waste or contains listed hazardous waste, disposal at a municipal or residual waste landfill in Pennsylvania would not be allowed. If it is nonhazardous, it would be considered to be residual waste.

Residual waste may be disposed at most of the municipal and residual waste landfills in Pennsylvania. However, waste acceptability and permitting requirements are facility-specific. With respect to a particular disposal facility, an environmental chemist in the Waste Management Program at the appropriate DEP regional office should be contacted for specific facility requirements. A list of our six regional offices and the counties each serves is enclosed.
